10 **Capital Improvement Budget and Program: FY 2010 to FY 2015**

12 **FOR** the purpose of adopting a capital improvement budget for the Fiscal Year 2010, and
13 a capital improvement program for the six-year period from July 1, 2009, to June 30,
14 2015.

16 **WHEREAS,** Section 6.16.030 of the Code of the City of Annapolis requires the
17 Annapolis City Council to approve a capital improvement program and
18 budget for each fiscal year on a six-year basis; and

19
20 **WHEREAS,** on April 27, 2009, the Annapolis City Council will have held a public hearing
21 on the budget for the City of Annapolis for the Fiscal Year 2010; and

23 **WHEREAS,** a capital improvement budget for the Fiscal Year 2010 and a capital
24 improvement program for the six-year period from July 1, 2009, to June 30,
25 2015, has been prepared and proposed by the Mayor and submitted to the
26 Annapolis City Council for its consideration and approval.

28 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that
29 pursuant to the provisions of Section 6.16.030 of the Code of the City of Annapolis, it
30 hereby adopts, as the Capital Improvement Program for the City of Annapolis for the six-
31 year period from July 1, 2009, to June 30, 2015, a copy of which is attached to this
32 Resolution and is made a part hereof.

34 **AND, BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the
35 Budget for the Capital Improvement Program for the Fiscal Year 2010, attached to this
36 Resolution and made a part hereof, be and the same is hereby adopted and approved.
