10 **A RESOLUTION concerning**

12 **Warren View in Acton’s Landing Park**

13  
14 **FOR** the purposes of establishing “Warren View” in Acton’s Landing Park; providing for  
15 the placement of two plaques honoring Mary and Marion Warren reflecting this  
16 designation; and, eliminating the prior requirement of a sculpture’s installation.

17  
18 **WHEREAS**, the Annapolis City Council passed Resolution R-14-07 on March 12, 2007,  
19 honoring the lives of Mary and Marion Warren; and

20  
21 **WHEREAS**, the resolution dedicated two benches in Acton’s Landing Park upon the Park’s  
22 conveyance to the City; and

23  
24 **WHEREAS**, the resolution further provided for the placement of a plaque and a sculpture  
25 of Marion Warren’s box camera; and

26  
27 **WHEREAS**, the creation of a sculpture of Mr. Warren’s camera is not feasible at this time;  
28 and

30 **WHEREAS**, the association of the site with the Warrens makes it appropriate to declare  
31 this part of the park “Warren View.”

33 **NOW, THEREFORE, BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that the  
34 area immediately surrounding the two benches dedicated to Mary and Marion Warren in  
35 Resolution R-14-07 be designated as “Warren View”;

1 **BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that a plaque  
2 recognizing Mary Warren as a preservationist and a plaque recognizing Marion Warren as  
3 a photographer be fabricated and fixed to the respective benches near the water at Acton's  
4 Landing Park;

5  
6 **BE IT FURTHER RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that a plaque  
7 recognizing the site of the memorial benches as "Warren View" be fabricated and installed  
8 on an appropriate surface.
