However, a person at least eighteen (18) years of age may serve Alcoholic Beverages while acting in the capacity of a waiter or waitress, and a person at least sixteen (16) years of age may be employed as a stock clerk. Persons under the age of twenty-one (21) shall not serve as a bartender or barmaid in any Licensed Premises, or in any other capacity which is solely related to a Tavern or bar notwithstanding any provision in these Rules and Regulations to the contrary.
