The Maryland Department of Transportation State Highway Administration (MDOT SHA) has the following comments:

General

- For the figures shown, please indicate where you got your data from.
- For the figures, please use a higher resolution image so that you can accurately read them.
- We agree with the recommended changes in the Traffic Impact Study procedures and Adequate Public Facilities Ordinance. Please keep MDOT SHA apprised with how those recommendations are implemented.

Chapter 2

- On Page 19, it is indicated that Forest Drive is owned by the The County. That is mostly correct - the County does have the roadway when it switches from MD 665 (Aris T Allen Blvd) to Forest Drive, with the exception of the portion between Chinquapin Round Road and Bywater Road. That ~700 foot portion is MDOT SHA facility.
- On Page 29, it is stated that the State owns and manages up to Chinquapin Round Road intersection. As stated previously, MD 665 technically extends to Bywater Road, another ~700 feet East.

Chapter 3

- Under section 3.3, there is an emphasis in working with the County. Because MD 665 is within the Study area, please include the State as another partner to work with.
